**Order of Special Election**

*(Orden de eleccion especial)*

**An election is hereby ordered to be held on November 5, 2013 in Road District One, Coryell County Texas for the purpose of:**

*(La eleccion se ordenó que se celebrarán el 5 de noviembre de 2013 en Road District One, Coryell County Texas con el fin de)*

**Authorizing Road District One to issue its bonds in the total sum of \$ 100,000.<sup>00</sup> and to impose annually ad valorem taxes on all taxable property in the district to pay the interest on the bonds and create a sinking fund to redeem the principal at maturity for the purposes of the purchase or acquisition of roads and the construction, maintenance, and operation of macadamized, graveled, or paved roads and turnpikes or in the aid of those purposes inside or outside the boundaries of the district.**

*(Autorizar un Road District One a emitir sus bonos en la suma total de 100,000.<sup>00</sup> y anualmente para imponer impuestos ad valorem sobre todos propiedad imponible en el distrito para pagar los intereses de los bonos y crear un fondo de amortización para redimir el principal al vencimiento a los efectos de la compra o adquisición de las carreteras y la construcción, mantenimiento y operación de macadamized, con grava, o carreteras asfaltadas y caminos o en la ayuda de los efectos dentro o fuera de los límites del distrito)*

This election will be held under the newly adopted County wide polling place program. A voter may vote at any of the following vote centers. You do not have to vote in the precinct that you live in.


